- 2) I, individually, and on behalf of my minor child and our respective heirs, successors, assigns and personal representatives, hereby agree to indemnify, defend and hold harmless the College and its employees, agents, servants, officers, trustees and representatives (in their official and individual capacities) from any and all liability, loss or damage they or any of them incur or sustain as a result of any claims, demands actions, cause of action, judgments, costs or expenses, including attorney's fees, which result from, arise out of or relate to my child's participation in the aforementioned Program, including travel.
- 3) I agree that this Release, Waiver, and Indemnity Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Indiana, and if any portion hereof is held invalid, it is agreed that the balance hereof shall, notwithstanding, continue in full legal force and effect.
- 4) I hereby acknowledge and accept that there are certain risks, including, but not limited to bodily injury, paralysis and death, that could result from my or my child's participation in the aforementioned Program at the College or off campus locations. I have knowingly and voluntarily decided to assume the risks of these inherent dangers in consideration of the College's permission to allow my minor child to participate in the aforementioned Program.

I further waive any claim for compensation of any kind for the College's use or distribution of photography and/or video footage of my child. I understand that this grant of permission and consent is irrevocable.
